Web Privacy Policy

Welcome to the website of ÜNLÜ Menkul Değerler Anonim Şirketi (“**ÜNLÜ Menkul**” or “**Company**”).

This section covers ÜNLÜ Menkul's information policies about personal data collected during website visits. In terms of personal data security, our company makes the following obligations. The information provided here applies to all digital media held by ÜNLÜ Menkul and contains details on the storage, protection, processing, and sharing of personal information submitted and collected for our activities and services.

ÜNLÜ Menkul's primary objective in this respect is to maintain the confidentiality of all information within our networks. All of the aforementioned information security procedures apply to all ÜNLÜ Menkul applications.

Protection, Use and Sharing of Personal Data

ÜNLÜ Menkul is an investment firm authorized to operate in the capital markets. Personal data are exchanged with the explicit consent of the relevant individuals in instances where the personal data are required and do not fall under the exemption, to the extent authorized by the laws and the relevant persons, including the Law No. 6698 on the Protection of Personal Data.

In order to ensure the confidentiality of the information transferred by users who visit its web pages, ÜNLÜ Menkul constantly updates its encryption architecture in line with technological developments and utilizes the most reliable encryption methods accepted in the current information sector on its systems. SSL (Secure Socket Layer) technology is used to guarantee that our security measures are effective within the scope of our activities and that sensitive data is delivered securely as encrypted. It's a security protocol designed to provide information security and secrecy across an SSL network. SSL ensures that the information provided can only be decrypted at the proper location. Before information is transferred, it is automatically encrypted and can only be decoded by the intended receiver. Verification on both parties protects the transaction's and information's confidentiality and integrity.

With the layered structure it has built in the application and system architecture, ÜNLÜ Menkul collects all of the data it has entrusted in a safe manner and protects it in the electronic environment applying strong encryption standards.

When ÜNLÜ Menkul collaborates with other organizations to provide support, these organizations are required to adhere to the ÜNLÜ Menkul's confidentiality policy and conditions, as well as the confidentiality provisions and additional security measures outlined in confidentiality agreements or contracts.

The most restrictive degree of authority and segregation of duties concept necessary for the job to be completed is used by ÜNLÜ Menkul staff to control access to guest and customer information.

In accordance with legal requests, ÜNLÜ Menkul distributes information collected in the course of the aforementioned operations with supplier businesses and official bodies with the knowledge and consent of the relevant person.
